### **Textile and Apparel Industry Information**

1. Brunei shall designate a government authority to collect and provide information regarding its trade and production in the textiles and apparel sector in accordance with this agreement.
2. No later than 180 days after entry into force of this Agreement for Brunei, Brunei shall provide to the United States a report describing textile and apparel production in Brunei. The report shall identify any enterprises in Brunei that produce textile or apparel goods, including the name, address, owners, and managers; describe the goods the enterprises produce; and provide information on where the enterprise sources materials, to the extent available. Where Brunei designates information in the report as confidential, the United States shall keep that information confidential and protect it from public disclosure. Upon request of the United States, Brunei shall provide the United States an opportunity to consult on the report.
3. Not less than once per year thereafter, unless otherwise decided by the United States and Brunei, Brunei shall provide an update or new report, as appropriate, with information on changes in the information provided to the United States regarding its textiles and apparel production and other information on the sector that the United States and Brunei decide.
4. No later than 180 days after entry into force of this Agreement for Brunei and annually thereafter, unless otherwise decided, Brunei shall provide to the United States data on its imports and exports of textile and apparel goods, including: the tariff classification; value; volume; and country of import or export.
5. Brunei and the United States may amend this agreement by mutual decision.
