Please accept our warmest congratulations on your appointments to the new College. We, the undersigned Ministers, would like to take this opportunity to express our joint position regarding the importance of digitalisation and the data economy for the EU's future, for the global competitiveness of European companies, and for job creation in the EU.

We have entered a new phase of globalisation, with digital transformation at its heart. Data have become the backbone of economic activity, trade and competitiveness, as well as a vital element throughout many companies' value chains. Businesses of all sizes across all sectors need to access, use and transfer data. Examples of such sectors are artificial intelligence, information technologies, food industry, manufacturing, resource extraction, transport and logistics, and the medical industry. It is crucial to establish a cross-border trustworthy space for data flows, access to data and data sharing partnership.

It is important to continue discussing future rules on cross-border data flows based on the needs and interests of European economic operators and consumers. We need effective tools to address digital protectionism in third countries while ensuring the protection of personal data. In this context, we would like to emphasise the importance of including rules on data flows in the EU's trade policy, its trade agreements and in particular in the ongoing plurilateral e-commerce negotiations in the WTO.

The WTO rules will create a stable global framework, enable businesses to harness the full potential of e-commerce, and ensure a level playing field. The e-commerce negotiations are of strategic importance in demonstrating the WTO's credibility and strengthening its function as a rule-making organisation. We welcome the fact that the EU has been playing a leading role since the beginning of the WTO negotiations. The Commission should continue to be proactive in these negotiations to support the competitiveness of EU businesses and their capacity to generate employment. Particularly, we encourage the Commission to engage proactively towards ambitious rules on data flows and, to this end, make use of the flexibility given by the negotiating directives.

Finally, we would like to underline that the relevance of e-commerce and the need for ambitious rules on data flows should also be reflected in other EU trade negotiations as well as in the Commission's future Trade and Digital Strategy. We wish you every success in your new role and we stand ready for future discussions in order to deliver a better future for European businesses and citizens.
